



## REGIONAL BREAKDOWN




## MATURITY BREAKDOWN

## MANAGEMENT COMMENTARY

Launched at the beginning of 2025, SG Credit Millesime 2030 benefited from exceptionally favourable timing, coming to market just after the rise in long-term interest rates. This supportive environment allowed the fund to build its portfolio under attractive market conditions and position itself with a competitive yield from inception. As of year-end, the NAV stands at €430 million, reflecting strong investor interest throughout 2025 and supported by an excellent performance of 4.38% since March. Over the fourth quarter of 2025, the fund continues to demonstrate solid momentum. The investment objective of the fund remains unchanged: to deliver steady returns over the predefined investment horizon by investing in bonds that generate environmental benefits and whose issuers follow strong governance and social practices. Overall, the fund offers an attractive, transparent, and defensive investment solution, supported by a conventional yield of 3.86%, a well-diversified portfolio of 74 issuers, and a high-quality credit universe.
