


REGIONAL BREAKDOWN




MATURITY BREAKDOWN

MANAGEMENT COMMENTARY (QUARTERLY)

The Fund continues to benefit from the favorable context of the corporate bond market and has progressed around 0.48% for the month, or +1.99% since launch. As of the end of June, the assets under management (AUM) of the fund continued to grow, reaching €285 million. In this context, the portfolio has been regularly rebalanced in line with the carry strategy and the target portfolio. Nevertheless, the fund remains opportunistic in its investments and favors the primary market whenever possible to capture the interesting premium offered by new bond issuances. Thus, new names have been integrated into the primary market to capture premiums, notably: • CESKE DRAHI 3.75% 28/07/2030: Major issuer in the infrastructure sector, benefiting from a strong financial position and government support. • CMA CGM 5% 15/01/2030: Global leader in maritime transport, CMA CGM shows strong resilience to market challenges, supported by proactive fleet management. • LAGARDE 4.75% 06/12/2030: Leading company in the consumer goods sector, known for its ability to innovate and maintain stable profitability. • Hybrid Repsol 4.5% perp call 26/03/2031: Key player in the energy sector, Repsol is committed to transitioning to more sustainable energies while maintaining a solid capital structure. The portfolio profile remains attractive in a declining rate environment, with good performance in the corporate bond market, a yield of 4%, and a duration of less than 4.3 years.
