WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of Moorea Fund

Term: The Sub-Fund has a recommended holding period of 5 years.

Objective:

Investment objective: The Sub-Fund Moorea Fund-Sterling Bond Fund Strategy objective is to generate a return which exceeds that of the Benchmark which is 50/50 split in Merrill Lynch 1 - 10 year UK Gilt Index TR and in (ii) Merrill Lynch 1-10 year Sterling Corporate Index TR.

Investment policy: The Sub-Fund invest in predominantly Sterling denominated assets (i.e. 90% of the assets of the Sub-Fund) primarily investment grade, fixed and floating rate bonds and other debt securities which, in the opinion of the investment Adviser, have a comparable credit quality issued by corporations in any part of the world or issued or guaranteed by any government, government agency, supranational or public international organisation in any part of the world. The Sub-Fund will invest in securities listed or traded on Recognised Markets.

SFDR Category: Article 6

Benchmark: The Sub-fund is actively managed with reference to the following benchmarks: 50% Merrill Lynch 1-10 years UK Gilt Index TR and 50% Merrill Lynch 1-10 years Sterling Corporate Index TR . The benchmarks are used for performance comparison.

Income: Distribution share class, the dividend is paid quarterly.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 3 years.

Currency: Your shares will be denominated in GBP, which is the Fund's base currency.

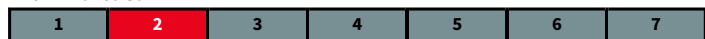
Processing and redemption orders: You can buy and sell your shares daily.

Depositary: Société Générale Luxembourg

Intended Investor: This share class is intended for all investors. The fund is dedicated to investors who have neither financial expertise nor any specific knowledge to understand the Sub-Fund but nevertheless may bear total capital loss. It is suitable for investor who seeks growth of capital. Potential investors should have an investment horizon of at least 3 years.

The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
