WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of Moorea Fund

Term: The Sub-Fund has a recommended holding period of 5 years.

Objective: Investment objective: The investment objective of the Sub-Fund is to provide a capital growth over a medium to long term.

Investment policy: This Sub-Fund seeks to provide mid to long term capital appreciation by investing in UCITS funds that pursue alternative investment strategies. The Investment Manager will get exposure to UCITS funds primarily specialized in the following alternative investment strategies: "Convertible Bond Arbitrage", Directional strategies such as "CTA & Global Macro", "Event Driven", "Long Short Equity", "Equity Market Neutral", "Fixed Income Arbitrage", "Long Short Credit". However, the Investment Manager reserves the right to select UCITS funds specializing in alternative strategies differing from the ones listed above and/or other UCITS funds.

SFDR Category: Article 6.

Benchmark: The Sub-Fund is actively managed without reference to a benchmark. For the purpose of performance comparison only, the return of the Sub-Fund will be compared to the following benchmark: HFRX Global Index.

Income: Accumulation share class, the dividend is reinvested.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 5 years.


Currency: Your shares will be denominated in USD, the Fund's base currency is EUR.

Processing and redemption orders: You can buy and sell your shares weekly.

Depositary: Société Générale Luxembourg

Intended Investor: This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seeks growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 5 years.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
