WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of SG IS Fund

Term: The Sub-Fund has a recommended holding period of 5 years.

Objective: **Investment objective:** The Sub-Fund seeks to provide long-term capital growth by investing primarily in equities of US sustainable companies or companies that demonstrate improving sustainable characteristics.

Investment policy: The Sub-Fund invests at least 90% of its assets (excluding cash and cash equivalent) in equities of companies that are domiciled, or carrying out the main part of their economic activity, in the USA. All the equities invested in portfolio will be researched and analysed from an ESG standpoint. The Sub-Fund will mainly invest in sustainable companies or companies that demonstrate improving sustainable characteristics.

The portfolio will invest in approximately 50 to 70 companies included in the S&P 500 index. Up to 10% of the portfolio could be invested in securities not included in the S&P500 index. The portfolio may also invest in Canadian companies.

SFDR Category: Article 8. The IM addresses ESG factors throughout the investment process, including research, company engagement and portfolio construction by incorporating a sector exclusion policy completed by an ESG Integration policy.

Benchmark: The Sub-Fund is actively managed with reference to the following benchmark: S&P 500 Index. The benchmark is used both for performance comparison and as a universe from which to select securities.

Income: Accumulation share class, the dividend is reinvested.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 5 years.

Currency: Your shares will be denominated in EUR, the Fund's base currency is USD.

Processing and redemption orders: You can buy and sell your shares daily.

Depositary: Société Générale Luxembourg

Intended Investor: This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seeks growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 5 years.

Société Générale Investment Solutions (Europe) is a management company licensed and supervised by the CSSF. Société Générale Investment Solutions (Europe) complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
