WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of SG IS Fund

Term: The Sub-Fund is of unlimited duration and may continue to operate indefinitely.

Objective and investment policy: Het Subfonds streeft ernaar om op lange termijn kapitaalgroei te realiseren over een cyclus (5 jaar) door te beleggen in een gediversifieerde en duurzame portefeuille van aandelen uit opkomende markten.

Het Subfonds zal ten minste 90% van zijn activa beleggen in aandelen en gelijkwaardige effecten van ondernemingen die zijn gevestigd in of het grootste deel van hun economische activiteiten uitoefenen in opkomende markten. Als opkomende markten worden beschouwd de landen die zijn opgenomen in de MSCI Emerging Markets Index. Er kan ook worden belegd in aandelen en gelijkwaardige effecten van ondernemingen die zijn gevestigd in, of het grootste deel van hun economische activiteiten uitoefenen in, ontwikkelde markten die aanzienlijke bedrijfsactiviteiten hebben in opkomende markten.

Het Subfonds zal gebruikmaken van kwantitatieve (d.w.z. wiskundige of statistische) modellen die eigendom zijn van de Beheerder om een systematische (d.w.z. op regels gebaseerde) benadering van aandelenselectie te realiseren.

De Beheerder zal bij de selectie van beleggingen rekening houden met principes van duurzaam beleggen via een combinatie van uitsluitingsgerichte ESG-screens, het gebruik van ESG-gegevens in de kwantitatieve modellen en de optimalisatie van de portefeuille op basis van duurzame en ESG-kenmerken.

Benchmark: Het Subfonds wordt actief beheerd met verwijzing naar de volgende benchmark: MSCI Emerging Markets net total return in USD (Bloomberg-ticker: NGDUEEGF index). De benchmark wordt zowel gebruikt voor prestatievergelijking als als universum voor de selectie van effecten.

Inkomen: Accumulerende aandelenklasse, het dividend wordt herbelegd.

Beleggingshorizon: Het risico en het rendement van het product kunnen variëren afhankelijk van de verwachte beleggingsduur. Wij raden aan dit product minstens 5 jaar aan te houden.

Valuta: Uw aandelen worden uitgedrukt in EUR, de basisvaluta van het Fonds is USD.

Intended Investor: This share class is intended for professional investors and eligible counterparties. The fund is dedicated to investors who seek growth of capital and may bear total capital loss. Potential investors should have an investment horizon of at least 5 years.

The Company is not required to make any payment to you in respect of your investment. If the Company was liquidated, you would be entitled to receive a distribution equal to your share of the Company's assets, after payment of all of its creditors. The Company has no obligation to make any payment to you in respect of the ordinary shares. There is no compensation or guarantee scheme in place that applies to the Company and, if you invest in the Company, you should be prepared to assume the risk that you could lose all of your investment. As a shareholder in the Company, you would not be able to make a claim to the Financial Services Compensation Scheme in the event that the Company is unable to pay you anything on its liquidation.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures assume you invest €10,000. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
