WHAT IS THIS PRODUCT?

Type: This product is a share of a Sub-Fund of Moorea Fund.

Term: The Sub-Fund has a recommended holding period of 5 years.

Objective: **Investment objective:** The investment objective of the Sub-Fund is to generate a total return which exceeds the SONIA rate by a margin of 3% p.a. over the medium to long term. To achieve its objective, the Sub-Fund will invest up to 100% in equity linked structured products and or their swap equivalent collateralized by Gilts. The Sub-Fund can use different investment instruments such as structured products, fixed income and derivatives such as swaps, futures, forwards and options. The Sub-Fund may also keep a portion of cash in the portfolio.

Investment policy: The allocation between investment instruments will be determined by market conditions and views of the investment team to achieve the investment objective. The Sub-Fund asset allocation will primarily be driven by macro-economic views determined by Kleinwort Hambros Investment Committee based upon equity valuations, momentum and sentiment prevailing in markets to determine the weights to allocate to each region / country / sector / style of management. The Sub-Fund's investment managers will then consider the volatility and correlation of each region / country / sector / style of management to best determine weights to allocate in respect of the target return of the Sub-Fund. The Sub-Fund is also authorized to invest in fixed income securities (up to 100% of the assets of the Sub-Fund) and in Cash (up to 10%)

SFDR Category: Article 6.

Benchmark: The Sub-Fund is actively managed, meaning it is not managed in reference to a benchmark. However, the performance of the Sub-Fund can be compared to the return of GBP Overnight SONIA + 3%.

Income: Distribution share class, the dividend is paid quarterly.

Investment horizon: The risk and the reward of the product may vary depending on the expected holding period. We recommend holding this product at least for 5 years.

Currency: Your shares will be denominated in USD. The Sub-Fund's base currency is GBP.

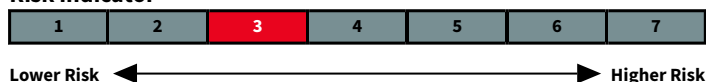
Processing and redemption orders: You can buy and sell your shares daily.

Depositary: Société Générale Luxembourg.

Intended Investor: This share class is intended for all investors. The fund is dedicated to investors who have neither financial expertise nor any specific knowledge to understand the Sub-Fund but nevertheless may bear total capital loss. It is suitable for investor who seeks growth of capital. Potential investors should have an investment horizon of at least 5 years.

Risk indicator

Société Générale Investment Solutions (Europe) complies with organizational and operational rules, in particular as regards capital requirements. A separate pool of assets is invested and maintained for each Sub-Fund. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the management company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the management company or any delegated service provider were to fail or default.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance. There is no direct link between the Company's share price and the costs that it pays.
